I understand that this waiver and release precludes my right of recovery of damages.

b. Upon entering the property, I attest that I am free of any symptoms of the COVID-19 virus and agree that if any symptoms occur while on CALF premises, I will promptly advise CALF, and vacate the premises.

I shall defend, hold harmless and indemnify CALF, their trustees, officers, directors, employees, agents and other volunteers, from and against all damages, claims, liabilities, causes of action, judgments, settlements, costs and expenses (including, but not limited to, reasonable expert witness and attorney fees) that may at any time arise or be claimed by any person as a result of bodily injury, death or property damage, or as a result of any other claim or cause of action of any nature whatsoever, arising from or in any manner connected with, directly or indirectly, the performance of my volunteer duties.
